INTRODUCTION

- 1 A US-Vietnam Bilateral Trade Agreement was signed in 2001 in advance of Vietnam's accession to the World Trade Organization, which was formalised in 2006. The US also has Trade and Investment Framework Agreements, which set the frameworks and principles for dialogue, that were signed with New Zealand in 1992 and Brunei in 2002.
